TERMS AND CONDITIONS

01. DEPOSITS

- a. The minimum deposit will be Rs. 5000/=
- b. Deposits are fixed for the period specified in the Deposit Certificate and cannot be withdrawn earlier.
- c. Deposits may be held in the name of the one person or, if so required, more than one person and can be made repayable jointly or severally or to the survivors.
- d. In the event of Deposits made by cheques, the deposit will be activated only subject to realization of the cheques.
- e. Any changes of address, payee and nominee or loss of fixed deposit certificate should be notified in writing to the company immediately.
- f. Any changes of address and / or loss of fixed deposit certificate should be notified in writing to the company immediately.
- g. The Company reserves the right to review the rates of interest in keeping with the market rates.
- h. Withdrawals should be notified only in writing to the company by the holder (s)
- I. If the Fixed Deposit is Withdrawn before the contracted period, interest will be paid at a penalty rate decided by the Management.

02. PAYMENT OF INTEREST

- a. Interest can be paid monthly, or maturity at the option of depositors. Interest will accrue at simple rates and shall be calculated and paid only at the end of the term on Fixed Deposits where interest is payable at maturity.

03. LOANS

- a. At the discretion of Management, depositors could obtain loans from their deposits. Interest and other charges will be levied on such loans at rates prevailing at the sole discretion of the Management.

04. RENEWALS

- a. If the company is not notified of any change with regard to the terms of renewal of the deposit or withdrawal, of such deposit on or before the maturity date, this deposit will, at the option of the company, be renewed for a similar period at the rates of interest prevailing on such date based on the instructions provided by the customer at the time of opening the Fixed Deposit
